1. The term of this contract shall be for the four month period commencing upon the date that this contract is processed by MFO. THIS CONTRACT WILL CONTINUE THEREAFTER ON A MONTH TO MONTH BASIS UNTIL AND UNLESS TERMINATED BY EITHER PARTY IN WRITING ONE WEEK PRIOR TO THE NEXT BILLING CYCLE. (Termination notice to MFO faxed to (702) 982-6265 or mailed to RTC@mikeferry.com)
2. By law you have the right to cancel this contract at any time prior to midnight on the third business day after the execution of the contract. To cancel, mail or fax the cancellation form (that will be provided to you upon approval of this contract) to MFO or send an email to RTC@mikeferry.com.
3. Any payment hereunder, if not timely made, shall bear interest at an annual rate equal to ten percent (10%) per annum until paid. In the event that any finance charge or fee imposed under this contract would exceed the maximum charge or fee permitted by any applicable state or federal law, then this agreement shall be deemed amended to reduce such charge or fee to the maximum lawful amount. In such event, such excess charge, if paid, shall be applied to reduce my outstanding obligation. In addition, a ten dollar (\$10.00) late fee will be charged on any installment not received within ten (10) days after its due date.
